### LACK OF SERVICES: EMFULENI LOCAL MUNICIPALITY

1. I refer to our telephonic discussion today. As discussed, we enclose herewith a copy of our letter to the mayor and the acting municipal manager dated 8 September 2017 from which you will note that the request was to respond by close of business today on the issues raised in paragraph 7 of our attached letter.
2. We requested you to issue a media statement regarding the matters raised in our letter and it would also be appreciated if you could deal with the following:
  - 2.1. The rumour that the municipality will be placed under administration.
  - 2.2. The alternative rumour that the Gauteng Provincial Government has appointed a municipal manager and a chief financial officer.
  - 2.3. The rumour that the municipality and Eskom are in negotiations (we have no similar information regarding Rand Water).
3. As discussed, frequent media statements setting out the facts would ensure that these rumours are not at the order of the day and we appreciate your undertaking to take urgent instructions and respond to our letter and to issue a media statement regarding the above and other relevant matters.
